**General**

The sixteenth International Aviation and Space Salon MAKS-2023 (hereinafter also referred to as MAKS-2023, the Exhibition, the Airshow) is held pursuant to Resolution No. 1846-r of the Government of the Russian Federation dated July 07, 2021 in accordance with Contract No. 23/CF/22 dated October 14<sup>th</sup> between the Ministry of Industry and Trade of the Russian Federation (the Official Organizer) and Aviasalon Joint Stock Company (the Organizer), address: Garnaeva street 2A, bld. 1, rm. 1, 2, Zhukovsky, Moscow Region, 140185, Russia. MAKS-2023 will be held in Zhukovsky Moscow Region in **July 18 – 23, 2023**.

These General Conditions of Participation in MAKS-2023 (hereinafter referred to as the General Conditions) are supplementary to the Terms and Conditions of Participation in Exhibitions Held at Transport and Exhibition Complex Russia (hereinafter referred to as the Terms and Conditions).

Payment must be made in RUR as a bank transfer.

Extra charge for the number of open sides of exhibition space and stand floors is calculated as follows:

- 10% for a stand open from 2 sides.
- 15% for a stand open from 3 sides.
- 20% for a stand open from 4 sides.
- Extra charge for lease of the 2nd floor - 30% of the rental cost of the total area of the second floor (without surcharges for open sides).

For preliminary guaranteed chalet booking at MAKS-2023 the Exhibitor shall make the application in online account - Application for exhibition space. After invoice issue the sum not less than 25% from the total chalet cost should be paid within 10 working days. After receiving the payment, the Organizer guarantees the possibility of providing the selected chalet module.

If the Exhibitor refuses the chalet the Organizer withholds 25 (twenty five) % of the total chalet cost.

**Special conditions for participation in the exhibition and demonstration (static display) programs**

- 80% of the cost of leased exhibition space for higher education institutions of aerospace and military-industrial profile, participants in the section “University Science and Aviation-Technical Creativity of Youth.”
- National pavilions pay for the leased exhibition space at the base price with no extra charge for the configuration of the stand (i.e. number of open sides, with the exception of two-story structures).

**Cost of participation in static display:**

Participation in the demonstration program provides placing the aircraft on a static display and/or participation in the flight demonstration program.

The leasing cost of static display area includes:

- An area at the static display (concrete or ground);
- Fire safety provision (fire extinguishers) in accordance with acting regulations;
- Grounding loop provision;
- Aircraft slots marking;
- Lighting in nighttime (only for concrete area);
- Support of arrival / departure including towing to / from the allocated aircraft slot.

Placing in close proximity to the aircraft awning structures and other temporary structures is charged additionally based on the cost of 1 square meter of lease of an open exhibition area under construction. The appearance and technical characteristics of the tent design are subject to the obligatory written coordination of the organizer.

A participant must not operate own power units and other ground service equipment without certification and admittance of the airfield chief operator.

### **Participation in Flying Display Program**

Aircraft arrival and departure, as well as their flight hours within the framework of the flying display program during the exhibition (18.07.2023 - 23.07.2023) don't involve extra payments with an exception of additional airfield services ordered by a Participant.

If an aircraft located at the static display area should take part in the flying display program, the aircraft towing from and back to the static display area should be ordered and paid for by a participant.

All flights that are not included into the adopted flying display program (familiarizing, training, testing, transportation and other) are made in accordance with acting Regulations of Ramenskoye Airfield and should be paid on the basis of direct contracts with Gromov Flight Research Institute according to their current tariffs. All exhibited aircrafts should depart from the exhibition grounds and static area displays no later than on **August 1<sup>st</sup>, 2023**. In case of delay participant should pay an overstaying fee according to the Gromov Flight Research Institute current tariffs.

### **Permission to participate in the flight and demonstration program**

Airplanes, helicopters, gliders, photo-gliders, lighter-than-air aircraft, kites, parachutes, flying model aircraft, aviation sports equipment or other equipment intended for use in airspace (in accordance with the Rules Air Traffic Control (ATC) are related to aircraft.

Participants willing to exhibit their aircraft(s) should fill in an application form for aircraft display (for each aircraft). Upon receiving the Application confirmation the participant will be provided with pilot instructions. In order to receive permission for aircraft arrival, exhibition and participation in demonstration flights the participant should submit the following documents (scanned copies):

- Aircraft's pilot-in-command application for the participation in flights according to the MAKS-2023 program;
- Airworthiness certificate;
- Emergency rescue designation scheme;
- a copy of the document confirming compulsory insurance in accordance with the Air Code of the Russian Federation;
- a copy of the document confirming third-party liability insurance in case of damage to the person or property for an insurance amount not lower than the following, depending on the aircraft weight:
  - up to 2 tons – in the amount equivalent to 1 500 000 USD
  - 2 to 8 tons - in the amount equivalent to 3 000 000 USD;
  - 8 to 30 tons - in the amount equivalent to 5 000 000 USD;
  - 30 to 100 tons - in the amount equivalent to 10 000 000 USD;
  - over 100 tons - in the amount equivalent to 25 000 000 USD;
- life and health insurance certificates of the flight personnel for the case of death or personal injury as a result of an aircraft accident for 75 000 USD for each crew member;
- valid certificate of the pilot and crew members, or a certificate for the right to fly given type(s) of aircraft;
- medical flight admission for each member of the crew;

- description and pattern of the demonstration flight;
- advertising (speaker) text and aircraft details for the demonstration flights' announcer.

Upon exhibiting the aircraft at the static display the Participant should oversee an installation of an information stand (standard) in the parking area, containing the general info and technical details of the aircraft presented. Participants may rent an information standard in a "technical services" tab in the Participant's online personal account.

Submitting the Application for participation in the flight program and static display, Participants shall provide the following information for placement on the Organizer's website and in the official application MAKS-2023:

1. Text description of the aircraft (200 characters maximum).
2. Logo of the manufacturing company.
3. Contacts of the manufacturing company (site, telephone).
4. 3D model of external appearance of aircraft displayed by your company (preferably in 3Dmax format). In case of refusal to provide, the Organizer reserves the right to publish any outline of the "aircraft" at discretion.
5. Information table for each aircraft to be displayed. To avoid errors in translation, the tables shall be filled in Russian and English.
6. From 3 to 10 photos of each aircraft exhibited with the following characteristics:
  - Resolution: 1900 x 1000 px
  - Image aspect ratio: 16:9
  - File type: jpeg, jpg, png
  - Volume: not more than 5 Mb

#### **Additional requirements to static display and demonstration program**

In order to avoid emergencies in the work of the Ramenskoye airfield and in order to ensure the safety of the flight program and the regularity of aircraft departures, Aviasalon JSC, organizes the following activities without an application from the Participant:

- Evacuation, removing or relocation the Participant's damaged or defect aircraft from the airfield;
- In case of contamination of airfield pavements - a set of measures and activities regulated by clause 5.1.12 of the NTERAT GA-93, including work on the elimination of contamination of the airfield pavement. Investigations regarding these accidents are conducted in accordance with the regulatory documents of the Ramenskoye airfield and relevant Statements. The Participant receives corresponding bills based on the Statements. The Participant is obliged to pay these bills within 5 (five) days from the date of their issue.

Upon the arrival the aircraft crew should submit one copy of the Consolidated boot list (CBL). In case of an absent or unclear CBL the cost of aircraft maintenance services (upon arrival) is calculated according to the projected full commercial load of the aircraft.

The Participant has the right to appoint a representative of the Participant, who is authorized to represent company during the exhibition on the territory of the Ramenskoye airfield, as well as to sign any documents arising in the process of the parties fulfilling their obligations when rendering services.

The Participant is obliged to notify the Organizer of the appointment of the Representative of the Participant

and attach a duly certified copy of the document assigning the power of attorney to the Representative. The Participant also confirms that pilots-in-command and other members of the crew of the aircraft have all the powers of the representative of the Participant regardless of whether they have the power of attorney from the Participant.

If for reasons beyond the Organizer's control the demonstration flight program is terminated or reduced, the costs incurred by the Participant are not reimbursed.

### **Demonstration of exhibits**

#### **Order of obtaining permission to demonstration of exhibits**

Production meeting the following requirements is allowed to demonstration at an exhibition

- corresponding to thematic of an exhibition;
- declared the Participant in Lists of exhibits (form 1.0, 1.1, 2.0);
- approved by the Organizer in the corresponding Lists of production allowed for demonstration at an exhibition.

Exhibits data (natural samples, models, advertising information and video records) planned to demonstration at an exhibition, the Participant has to send in time to the Organizer's address as follows:

- filled form in a Word format and scanned copies of lists of exhibits, Participant directs to e-mail of the Organizer (list@aviasalon.com, responsible person: Lazutkina Tatyana, t.: 8 (495) 925-64-64, ext. 535);
- signed and stamped copies of the lists of exhibits the Participants should send to the postal address of the Organizer: Garnaeva street 2A, bld. 1, Zhukovsky, Moscow Region, 140185, Russia;
- the 2nd kit of copies Participant has to have at himself at registration of permission to transportation of production on the territory of an exhibition.

#### **Military exhibits**

For foreign Participants military exhibits are subject to licensing. For the purpose of simplification of customs procedures and timely obtaining the license the Participant needs to provide the list of exhibits of military and dual purpose in a form 3.0 or to fill and sign the obligation that his exposition doesn't contain military product samples.

The term of providing lists (forms 3.0) - no later than April 18, 2023.

#### **General rules of demonstration of exhibits**

Exhibits are located on the exhibition area and/or on the static display rented by the Participant. Exhibits can't be moved on other exhibition areas without coordination with the Organizer. Any movements of exhibits end no later than 20:00, July 17.

Exhibits, including aircraft shouldn't leave places of exhibiting until closing of an exhibition without written permission of the Organizer.

Are forbidden to demonstration: military weapon, ammunition, explosives, combustible and radioactive materials. The separate capacities containing fuel or air-fuel mix can't be exhibited or transported in the exhibition zone and in zone of the static display of aircrafts. Movement of vehicles of participants in zone of demonstration of exhibits on the static display in opening hours of the exhibition isn't allowed.

All exhibits demonstrated on the open exhibition area and/or a static display of the exhibition has to be supplied with information plates with the name and the description of the exhibit in Russian and English languages.

The organizer has a right to refuse to the Participant demonstrating products, the information on which is not provided in the corresponding lists (form 1.0, 1.1, 2.0, 3.0),

The organizer can insist on removal of exhibits if they aren't included in the corresponding lists, can be dangerous to people around or are incompatible with the exhibition purposes. If the Participant doesn't fulfill this requirement, the Organizer has the right to remove such exhibits by own efforts, but at the expense of the Participant, undertaking in case of need the measures provided by current laws and the presented General Conditions of Participation.

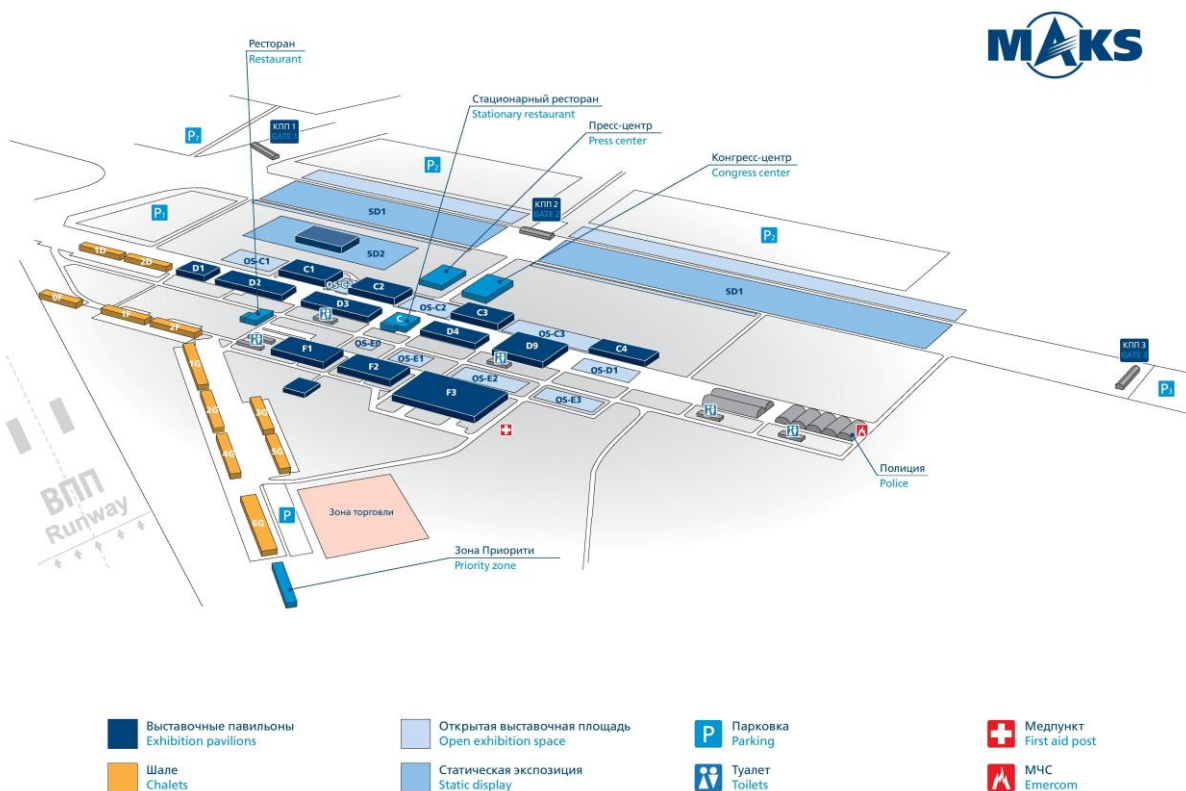

**General conditions of participation in sponsorship programs**

Terms of each sponsorship agreement will be discussed on an individual basis and are not a public offer. For sponsors with the similar status (category) of participation, a concept of equal presence at the Salon will be implemented. The above sponsor programs are not final and may change based on the Sponsor’s needs and the Organizer’s possibilities.

**Trade in the exhibition complex**

The sale of foodstuffs and souvenirs on the territory of the exhibition complex is possible only upon receipt of accreditation from the Organizer as a Trading Participant.

Foreign companies can only retail through their Russian representative offices.

Trade at exhibition space, open exhibition spaces and in the static exposition area is prohibited.

**Payment procedure**

All payments for participation in the exhibition pursuant to the concluded contract for residents of the Russian Federation should be made in Russian rubles (RUR) by transferring to the Organizer's settlement account.

Non-residents of the Russian Federation must make payments in Russian rubles (RUR) by transferring the designated sums to the Organizer's checking account.

State and local taxes, customs fees, duties, dues and tariffs payable pursuant to the concluded contract of participation in the exhibition shall be paid at the Participant's expense.

The value added tax (VAT) at the rate of 20% shall be added to all payments except for the cases prescribed by the laws of the Russian Federation and international treaties.

Extra services ordered during the exhibition days will be rendered by the Organizer on condition of 100% pre-payment.



**Contract termination**

The Organizer has the right to unilaterally terminate the Contract in the following cases:

- There is no funds receipt to the account of the Organizer from the Participant within the period specified in the Contract;
- Participant uses the provided exhibition space for other purposes;
- in other cases provided for by the Contract and the current legislation of the Russian Federation.

From the moment of termination of the Contract on the above grounds, the Organizer has the right to use the exhibition space allocated to the Participant at its own discretion.

If the Participant refuses to participate in the Exhibition 60 days or more before the start of the event, the Organizer withholds the cost of the registration fee and an amount of 25% of the cost of the rented exhibition space and / or chalet, in accordance with the concluded Contract.

The Participant's refusal to participate in the Exhibition 60 days or less does not entail a refund of the funds transferred by the Participant under the Contract. The funds transferred under the Contract at the time of sending the corresponding notification are subject to withholding by the Organizer to cover the costs incurred and compensation for the losses incurred.

In case of cancellation of the Exhibition 4 months (or less) prior to its holding due to circumstances that occurred through no fault of the Organizer, the Organizer notifies the Participant in writing. In this case, the Organizer's obligations arising from the concluded Contract become invalid. The Organizer returns to the Participant 50% of the cost of services, rent of exhibition space and / or chalet in accordance with the concluded Contract. Losses incurred by the participants, in this case, are not subject to compensation by the Organizer.

In case of cancellation of the Exhibition more than 4 months before its holding due to circumstances that occurred not through the fault of the Organizer, the Organizer shall notify the Participant about this in writing. In this case, the Organizer's obligations arising from the concluded Contract become invalid. The Organizer returns to the Participant all the funds transferred in accordance with the concluded Contract except the registration fee.
